DISCUSSION

Informal talk about 2012 contest and planned improvements for 2013. Dinner provided by the Netherlands Hilton in the Orchid Room

9 bands have reserved rooms at the host hotel (Hilton) for 2013, and there are rooms for 4-5 more. NABBA bands exceeded the contracted number of rooms during the 2012 contest, which is great. For 2013, bands/bandsmen are encouraged to work directly with Peggy Kee (peggy.kee@hilton.com) to book their rooms. If the Hilton is unable to provide rooms for all NABBA members who want them, the hotel will help them find rooms in other area hotels.

The 2011 contest in Grand Rapids cost NABBA \sim \$13K, but we were able to recoup that in Cincinnati in 2012 thanks in large part to the cooperation of the hotel and the Masonic Temple. The Hilton also donated \$2,000 towards the cost of the performance venue. The Cincinnati CVB, Hilton Netherlands, and Masonic Temple are all eager to have NABBA in town.

Vendors at the 2012 contest expressed a desire to have easy access to coffee, burgers, etc. The Hilton is currently talking to 2 non-profits and hope to have vendor carts with coffee, soda, and bakery fare at the venue itself. The CVB also hopes to be able to allow food trucks in front of the venue in 2013.

Vendors were not pleased with the fact that customers could not play horns at their tables during the 2012 competition. One consideration is to move the vendors to the 3rd floor of the venue, and to separate the "noisy" and "quiet" vendors.

The Taft Theatre is next door to the venue. Possibility that the lower-level bands could perform there on Saturday rather than on the 6^{th} floor of the Masonic temple (where acoustics were not great for the judges). Alternately, the judges in the 6^{th} floor venue could just move down from where they sat in 2012 (extreme top level). Doing this would block some seats, but the bands are there to be scored – adjudicators trump audience.

NABBA is considering putting in a temporary wooden floor at the main stage and possible open adjudication. Both moves are to enhance the adjudicators' audio experience.

Cincinnati is extremely interested in having NABBA return in 2015 & 2016, and also made a proposal that NABBA move there permanently.

RECORDING & FILMING FOR 2013 CONTEST

MULTIPLE PRESENTERS

DISCUSSION Still photography, video and audio recordings for the 2013 contest

DVDs were made of the bands in the 2011 contest with the understanding that they could be copied, shared online, etc. Mechanical rights were not secured by the recording company, however – distribution is not legal. If the recording company secures mechanical rights, however, that company can post videos online.

It would be desirable to have a film company put together some sort of documentary-type film of the 2013 contest to be used to introduce NABBA to a wider audience – particularly Canada.

Frank Washburn has been and will continue to be NABBA's official band photographer if that is his wish. Frank has previously expressed an interest to continue taking band photos.

Audio recordings have been made at contests, with the stipulations that each band which agrees to be recorded should receive multiple copies of the CD, that NABBA should receive a copy for archival purposes, that mechanical rights will be obtained, and that the recordings will not be sold online. The previous recording company may not have abided by these stipulations.

CONCLUSIONS

NABBA wishes to record as much of the event as possible while respecting the wishes of member bands and understanding the need to secure rights for any recordings.

2013 TEST PIECES

STEPHEN ALLEN

DISCUSSION

The music committee worked over the summer to select the 2013 test pieces. Steve went over each piece, gave insight into the committee's thoughts, and recommended that the pieces be approved by the board.

There was a desire for the Championship Section test piece to be more conservative and "easy to listen to," in part to help build momentum for a return to Grand Rapids in 2014. It is vital to maximize participation at the Grand Rapids venue. The First Section piece was chosen in part because of its difficulty. First Section bands are "bumping up against" the Championship Section, and their test piece should reflect this.

The Second Section piece was chosen in part to commemorate its 100th anniversary as the first original composition to be used as a test piece.

APPEAL TO CANADIAN BANDS

STEPHEN ALLEN

DISCUSSION

We've lost a great deal of recognition from Canadian brass bands and would like to encourage more Canadian bands to get involved with NABBA, particularly during the 2014 contest in Grand Rapids

Steve requested \$800 to attend the Hanaford Festival as a representative of NABBA. Randi and Steve Bulla are also planning to attend. Our NABBA displays and brochures should be available at that festival, and Theresa McDonald (former board member in Ontario) may be willing to create flyers.

To generate interest among Canadian bands, we'd like to offer certificates to 6 Canadian representatives to attend the Cincinnati contest in 2013 (two hotel nights and tickets to the championships).

Moved (Randi) and seconded (Raquel) to appropriate \$800 to send Steve to Hanaford Festival. Motion passed with 1 opposed and 1 abstention.

CONCLUSIONS

Moved (Jim) and seconded (Nigel) to provide 6 certificates for hotel accommodations and tickets to the 2013 NABBA Championships in Cincinnati for Canadian brass band representatives. Motion passed with 1 opposed.

GENERAL BUSINESS

MULTIPLE PRESENTERS

Full board discussion of items addressed in committee meetings

Figs. Clinic/Conference — Should we have a presence there? While the exposure of Midwest is great, it is with a supersive (\$1050 for a booth), and we might be better served to concentrate first on developing regional solo & competitions.

Semipatitions/championships (US Open, Great American, new National Contest in KC) — Our goal is to promote brass sensing, and we should view other organizations in that light, offer to provide assistance, partner with them to form segment S&C competitions, etc.

Magazial SAE: Development committee wants to get the ball rolling on regional S&Es with the hope of growing NABBA into assistant contests, developing players, and shedding the "NABBA is just a contest" image. S&E's are not intended to be many makers. Hopefully, regionals can develop into a feeder system for the annual S&E championship ("best of the bast"). We need to pinpoint the best venues close to the center of each of 8 US and 3 Canadian regions. Facilities must be free to NABBA – we can't afford to pay for 11 regionals. Adjudicators should be chosen by local musicians working with a NABBA representative. The training that Steve mentioned could help develop a pool of adjudicators. Entry fees must be enough to cover the cost of a NABBA membership.

Cooperation with other groups for S&E: We should look into partnering with the Music Teachers National Association to promote regional S&Es at each states (existing) S&E. Should also work with groups like ITG, ITG, ITEA, etc.

Timeline: Spread out over the year, avoiding college breaks if possible. Good starting point would be 11/2013.

Special thanks to Randi Bulla for preparing a detailed proposal regarding S&E.

Questions: How do we get bands to the competition? Specifically those that have stopped coming. Should we adopt some sort of a ranking system to sort bands into sections based on previous three years of competition? Can we help show them how to raise funds? Why did they stop coming? Why did they come in the first place? Has NABBA changed? Should we vet bands' own-choice selections? What happened to the regional NABBA reps? Can we bring them back and make them more proactive? Do we have personal contacts with people who can help us walk the line between brass banding and corporate sponsorships?

The "People's Choice" award seemed to go over fairly well in 2012 and we'll try it again in 2013.

Three-year Rule: Some discussion about reinstituting the 3-year rule, which stated that a band winning its section three years in a row should move up a section or sit out a year.

Adjudicators: One more adjudicator is needed for the 2013 contest.

Adjudicator comment sheets: The judges want to be able to alter their scores as the day goes on. This is currently allowed, but the judges may not be aware of it. We're not sure what the controller (Jim Buckner) is telling the judges. Keith Wilkinson can help with this going forward. Related: We will ask Keith Wilkinson to come up with a rubric for what the numerical scores actually mean.

Weighting: Currently, the test piece is worth 60% of a band's overall score. The contest committee voted to keep this in effect.

Timing: Contest committee voted to table discussions regarding changing the timing between bands, particularly on Saturday night Championship Section performances. On Friday night, everything is timed. On Saturday night, there is not specific timing for getting a band on the stage.

Board responsibilities at the contest: Board organization has faltered in recent contests. We need to be more proactive in ensuring that everything runs smoothly.

Funds are available to reimburse board members for the hotel costs associated with this meeting.

CONCLUSIONS

Moved (Randi) and seconded (Betsy) to continue discussion of the 3-year rule online and vote in spring of 2013. Motion passed with 1 opposed.

Moved (Jim) and seconded (Randi) that the board is reimbursed for hotel expenses for this meeting. Motion passed unanimously. Provide Jim with hotel receipt for reimbursement.
