- Welcome and remarks by Randi Bulla (6:40 p. m.)
- DEMONSTRATION of Mobile app by Crowd Compass via conference call. (6:45-7:25 p. m.) Mobile App would be implemented for 2017 Championships Cost of \$1500-\$3000 which would go down after the first year and templates are set. No decision was made at this time, but the presentation was relatively well received
- TOUR Site visit of Embassy Theatre showing renovations and changes from 2015 Championships (7:30 p. m. -8:20 p. m.) led by Jared Duymanic of the Embassy Features were newly renovated 5th floor used for case storage and new passageway to stage.
- ASSIGNMENTS for announcers and proctors (Betsy Jones) (8:20 p. m.)
- ASSIGNMENT and discussion of runners and use or recording equipment (8:30 p. m.)
- TREASURER'S REPORT (Ron Lutterbie) (8:40 p. m.) NABBA is on solid financial footing. Sponsorship from Sweetwater Sound for next three years was noted and appreciated. Financial update was approved by unanimous vote.
- FALL BOARD meeting date was set for Fri-Sun Sept 9-11, 2016 in Fort Wayne. (8:50 p. m.) Vote was 14 yes 1 abstain
- DISCUSSION led by Randi Bulla and Betsy Jones on Committee reorganization. (9:00 p. m.) They will work on setting up sub-committees under the banner of the contest committee. Possible sub-committees could be: Vendor, Program, Communications. Etc. ACTION-No decision was made as this will be an on going process and will be revisited at the Fall board meeting.
- REPORT- Music Committee reorganization led by Kevin Stees (9:15 p.m.) Kevin suggested possible changes to the music committee makeup. Some possibilities are:
 1. Use current board members but expand the committee to 4-6. No committee member will be involved in choosing the test piece in their band's section.

2. Use band members of non-competing bands as the make-up of the committee.

3. Use non-board members familiar with brass band repertoire as make -up of the committee. Ron Holz was cited as an example.

ACTION- The Music Committee serves at the discretion of the President and in the following weeks a decision will be made as the direction and make-up of the Music Committee.

- DISCUSSION of documentation of Board members tasks. (9:40 p. m.) ACTION-Each board member was asked to enumerate what they do on the board and submit to Randi Bulla in the reorganization of committees.
- DISCUSSION of Electronic Entries (9:45 p. m.) The consensus is that this is a must for the 2017 Championships for both band, solo/ensemble entries and vendor applications. ACTION- Joel Collier has volunteered to work on this with Ron and Anita
- PROPOSAL from Ron Lutterbie to simplify the band entry fees. (9:50 p. m.) He suggested a one fee platform regardless of band size. This would eliminate the need to reconcile at the Championships. This should be begin with the 2017 Championships entries. ACTION- Ron will present a model of this soon.
- DISCUSSION of 2017 Rules Changes. (9:55 p. m.) ACTION- Board is encouraged to consider the following:
 - 1. Statement of performance times with an earlier contest in 2017 (March 10-11)
 - 2. Enforcing deadlines of entries in both band and solo/ensemble events
 - 3. Enforcing deadlines for late and /or unnumbered scores'
 - 4. Choice pieces must remain anonymous
 - 5. Social Media and choice pieces
 - 6. Who is responsible for counting musicians on stage
- ELECTIONS (10:00 p. m.) ACTION Anita was assigned chair of nominating Committee and will make recommendation for this years Board elections. Board members should contact her as to their intentions.
- TABLED (10:05 p. m.) Board is asked to consider these items for further discussion:
 - 1. USCIS tax issue and IRS filing
 - 2. Regional solo and ensemble contest
 - 3. Possibility of adding 4th section or Explorer section
