• Regulatory- will make contest rules changes. Will make by-law change recommendations. Established OCT 17 and OCT 31 deadlines for rulechanges. Gena suggested an amendment in the by laws so that board members need to attend 3 consecutive meetings. ACTION – Nigel will work on minimum and maximum performance time for each section for the 2017 Championships

All forms and rules and bylaws will be accessible to board members in google docx

• **Development-** Vendors will now be called "Partners" and will be offered different levels of sponsorship. Will work with Visit Fort Wayne to develop more local

"partners". Betsy will look into grant writing for NABBA. Development committee will not only try to raise money but will make recommendations on how to spend money. Some suggestions were development of regional solo and ensemble contests, a west-coast NABBA regional, more teaching and youth group development.

- Communications- Outreach will be a goal. Outlets for communications are: Brass Band Bridge, Web site, Twitter, Insta gram and possibly a You Tube channel. ACTION committee will develop a time line for registration dates: NABBA 17 registration will open Oct 14 for a trial run and be fully up and running for all groups open Nov 1. Early registration will closes Dec 23 with final registration due on Jan. 6, 2017. the committee will work on a YOU TUBE video for each band the new registration procedures with the Embassy Thaetre. It was also suggested to have the new NABBA 17 ap and Pocket companion up and running for the 2017 Championships. Jeremy volunteered to do the video.
- **Logistics-** made some recommendations for the 2017 Championships: Hire labor to move equipment, work on improving acoustics in Grand Wayne Center performance area, move judging area in Embassy to center of mezzanine, Judges escorts to be assigned by Barb Burtch, have a venue manager in each major area (Embassy Theatre, Grand Wayne Center, Partners vendor area). Recommend using Soundwaves for the recording contract for 2017 with an option for 2018. ACTION- Dave Jones will act as partner vendor coordinator and work with Anita Cocker-Hunt in developing a "partner" program.
