- 3. All applications will remain securely on file with NABBA. If you are not selected for a Board position when you first apply, you may be contacted when openings occur to determine your continued interest and will be invited to reapply.
- 4. Board members will be expected to participate in at least one designated committee and to participate in NABBA functions during the year. Board members are expected to attend in person and virtual Board meetings throughout the year as well as other committee meetings / calls for vote, as necessary.
- 5. Board members are expected to attend and work at the annual contest. This will be scheduled around any performances you are involved in.
